



COVID-19: Community Health Update – April 1, 2020

All District facilities, playgrounds, parks, trails, athletic fields, courts, and restrooms are closed to the public until further notice.

If you choose to use open spaces, please practice physical distancing and NOT gather in groups.

If you have any symptoms, STAY HOME and DO NOT use public spaces.

COVID-19: Community Health Update – March 23, 2020

Until further notice,

- All programs and events are cancelled.
- Playgrounds at all parks are closed, including school district playgrounds.
- Woof Run Dog Park opening has been delayed.

Employees are working on a limited basis or remotely in response to Governor Pritzker's stay-at-home order through April 7, 2020.

COVID-19: Community Health Update – March 21, 2020

Due to the current COVID-19 situation, we are delaying the opening of Woof Run dog park, which was scheduled to open on April 1, 2020. We are continuing to monitor recommendations from the CDC, county health departments and local leaders with regards to the current situation. Once the threat has cleared, we will notify the public that they can complete the registration form for Woof Run and it is safe to enjoy our dog park.

Per Illinois Executive Order 2020-10, all Sugar Grove Park District **playgrounds are closed to public use** until further notice.

According to the order, individuals may leave their residences to engage in outdoor activity such as walking, hiking, running or biking and may go to public parks and open outdoor recreation areas IF they comply with Social Distancing Requirements, but playgrounds must close.

COVID-19: Community Health Update – March 20, 2020

The Sugar Grove Park District has canceled its programs and closed ALL facilities to help limit the spread of the coronavirus (COVID-19). Full closures go into effect at end of business on Friday, March 20. We are continuing to monitor recommendations from the CDC, county health departments and local leaders with regard to the current situation.

To be clear, these closures and cancellations include:

- Cancellation of all programs and events hosted by Sugar Grove Park District.
- Closure includes all parks along with Woof Run dog park. PLEASE NOTE: We're not actively maintaining parks and trails during this event. Users can make their own decisions in regard to open space and social distancing.

As always, we need your help in keeping the parks clean, safe and free of vandalism. If you find any broken equipment, or have any other safety concerns about the parks or facilities, please contact the Park District at (630) 466-7436. If you see vandalism occurring in the parks please contact the Sugar Grove Police Department by calling the non-emergency number 630-466-4526.

COVID-19: Community Health Update – March 13, 2020

Sugar Grove Park District staff is closely monitoring the evolving situation with COVID-19 (coronavirus). We have been receiving updates regarding COVID-19 from our Park District Risk Management Agency, Kane County Health Department and the Illinois Department of Public Health.

Your health and safety are our top priority! While we are not aware of any exposure to COVID-19, effective today, out of an abundance of caution, we have taken the following steps to protect the safety and well being of our residents and employees:

1. CARE programs at all Kaneland Elementary Schools will continue to be held based on the school schedule and our ability to staff the program. If school is cancelled,

CARE will be cancelled. Additional protocols have been initiated at CARE to limit exposure as well.

2. All other Park District recreation programs held at Kaneland Schools are cancelled through the end of March.
3. Youth basketball season is cancelled including the end-of-season tournament.
4. All Park District programs held at the Sugar Grove Township Building are cancelled through the end of March.
5. We are still evaluating programs held at independent contractors' facilities.
6. To help reduce the exposure to our administrative staff, and to ensure services, we will continue to host regular office hours at the Repede Center, but through electronic means and over the phone only.
