Director Pritchard reported that staff are working three days in the office and have the flexibility to either telework or work in-office for the remaining hours of their full-time schedule.

B. Parks Update

a. Hannaford Farm Park

Tabled until all Commissioners are present.

b. Dugan Wood Park

Director Pritchard updated the board about a project at Dugan Woods Park storm water retention pond, to include removal of invasive plants and reseed with native species to stabilize the banks of the pond, and improvements in order to mow area surrounding pond.

c. Seal Coating Projects

Seal coating has been done at several areas, including at the Repede Center, Prairie Building and Strubler Park basketball court.

d. Drain Tile Replacement at SGSC

Legal counsel for the Park District, advised the Park District that it is not obligated to pay for drain tile replacement at the SGSC as part of larger project planned by Sugar Grove Drainage District and Kane County. The Park District will allow such work to be done on its property within the SGSC.

C. Recreation Update

a. Unity in the Community Chalk Art Campaign

Photos of chalk art designs created by residents over the Fourth of July weekend were posted on the Park District's website.

b. Virtual 5K Run

This year's 5K Run will be a virtual event. Registration will take place on-line, run/walk times can be posted on-line, and t-shirts (redesigned with a masked runner) are available for on-line purchase.

c. Potential Daycare Partnership

The Park District is considering a request from the Kaneland School District to operate daycare services for it. Director Pritchard contacted legal counsel who advised the Park District to inquire of DCFS, if the Park District would need to be DCFS licensed or possibly be exempt. The District is waiting to hear back from DCFS.

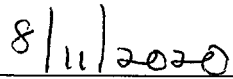
Commissioner Carmody made a motion to adjourn. Commissioner Walker seconded. President Eby adjourned the meeting at 8:09pm.
