Director Pritchard stated that the term of three commissioners will expire in the spring of 2021.

B. REVISED 2021 Budget & Levy Schedule

- a. Budget Review & Discussion – September 14, 2020
Discussion took place regarding the 2021 Budget and the impact of COVID-19 on the budget. Discussion included the need for alternate program space/facilities due to COVID-19 related loss of facilities normally used, generating new suggestions for program space/facilities to be investigated, the need to provide programs and community services to residents, especially during COVID-19, staff positions, and the Board’s responsibility to use of tax revenue, and the Park District’s Master Plan. Discussion on the 2021 budget will continue at next month’s Park District meeting.
- b. Tax Levy Ordinance #20-03
By consensus, the Board agreed to adjust the dates of the Tax Levy Ordinance #20-03, as follows:
 - Review and approve estimated tax levy for 2020 Tax Levy Year – adjusted from September 14, to October 12, 2020
 - Levy available for public review for 20 days – unchanged
 - Truth in Taxation public hearing – adjusted from October 12 to November 9, 2020
 - Tax Levy ordinance approval – adjusted from October 12, to November 9, 2020
- c. Budget & Appropriation Ordinance #20-04 for 2021 fiscal year
By consensus, the Board agreed to adjust the dates of the Budget & Appropriation Ordinance #20-04 for 2021 fiscal year, as follows:
 - Review tentative ordinance – adjusted from September 14, to October 12, 2020
 - Ordinance available for public inspection for 30 days - unchanged
 - Public hearing – adjusted from November 9, to December 14, 2020 at 7pm
 - Budget & Appropriation Ordinance approval – adjusted from November 9, to December 14, 2020




Commissioner Becker made a motion to adjourn. Commissioner Kinsland seconded. President Eby adjourned the meeting at 8:52pm.
